Law of the Republic of Moldova No 101 dated 26 May 2016 on amending certain legislative acts

The Law amends the Law No 845 dated 3 January 1992 on entrepreneurship and enterprises. The amendment stipulates that the company name may be used as a trade mark. This trademark need to be subject to registered in an ordinary procedure according to the Law on protection of trademarks.

Law of the Republic of Moldova No 106 dated 26 May 2016 for amending and supplementing certain legislative acts

Filing of a false complaint to a criminal prosecution authority in order to accuse a person of committing a crime is now criminalized. Previously, criminal law punished only submitting of a knowingly false denunciation.



Law of the Republic of Moldova No 125 dated 2 June 2016 on Moldova's accession to the Agreement on Government Procurement and to Agreement on Government Procurement amended by the Protocol amending it

Republic of Moldova acceded to the Agreement on Government Procurement done at Marrakesh on 15 April 1994, as well as to the Agreement on Government Procurement amended by the Protocol amending it, done at Geneva on 30 March 2012.

Marrakesh Agreement applies to any law, regulation, procedure or practices relating to any procurement performed by entities. The Agreement applies to procurement by any contractual means, including through such methods as: purchase or rent, lease or installment sale, with or without an option to purchase, including any combination of products and services.

Geneva Agreement applies to any measures on covered procurement regardless of whether is carried or not exclusively or partially by electronic means.

Government Decision No 774 dated 20 June 2016 on prices of socially important products




The Government approved Regulation on formation of prices for socially important products ("The Regulation"). According to the Regulation, products are sold using freely set prices, except for socially important products. Such products are subject to state measures of price regulation. The new rules apply to all entities of supply chain of socially important products, unless otherwise provided by law.

The following falls under the category of socially important products: bread up to 600 grams, loafs (padlock-shaped) up to 300 grams, cottage cheese with a fat content of up to 5% including, without additions, buckwheat, butter, rice etc.

The following manner of price formation on the domestic market is established for socially important products:

- socially important products are sold at purchase prices/supply prices by applying trade margins not exceeding 20%, except for bread and loafs for which trade margins shall not exceed 10%;
- socially important products, both imported and domestic which have undergone processing in commercial units are sold with trade margins not exceeding 40% from the purchase price/supply price.
